### Summary of Registration Requirements

Application for Kitten registration must be made within 12 months from the date of birth of the Kitten.
Kittens will not be registered after 12 months from the date of birth.
A Kitten will not be registered Neuter or Spay unless a copy of the Veterinary De-Sexing Certificate is attached
If the Sire is not currently registered with CATS NSW Inc. a copy of the pedigree certificate from a recognised governing body is required
If the Sire is not owned by the breeder making application for Registration a Stud Certificate is required
If the Sire is not on the CATS NSW Inc. database an additional fee of \$15.00 will apply
Prefixes must be registered in the same name as the owner/s of the Dam.
All Dams must be registered with CATS NSW Inc.
If a breeder wishes to transfer Kittens into the names of the new owner/s at the time of registration an additional fee of \$10.00 per Kitten must be paid. All certificates will be posted to the new owner/s.
An additional fee of \$10.00 for postage and handling will be charged if incorrect information is supplied resulting in the return of the application to the breeder.
