Summary of Registration Requirements

	Registration Requirements
1	The Application Checklist on the front page MUST be completed and returned with the completed registration forms.
2	Application for kitten registration must be made within 12 months from the date of birth of the kitten.
3	Kittens WILL NOT be registered after 12 months of age
4	Kitten will not be registered as de-sexed (neuter/spay) unless a copy of the Veterinary Desexing Certificate is sent with this application
5	If the sire (stud) is not currently registered with Cats NSW Inc. a copy of the pedigree from a recognised governing body must be sent with this application
6	If the sire (stud) is not owned by the breeder/s making the application a Stud Service Certificate is required (these can be found on the Cats NSW website under forms
7	If the sire (Stud) is not on the Cats NSW Inc database and additional fee of \$15.00 will apply. <i>(Please check with the Cats NSW Registrar if unsure)</i>
8	Prefixes must be registered in the same name as the owner/s of the Dam.
9	All dams must be registered with Cats NSW Inc
10	If a breeder wishes to transfer kittens into the names of the new owner/s at the time of registration an additional fee of \$15.00 per kitten must be paid. All certificates will be returned to breeder for distribution to new owners.
11	An additional fee of \$10.00 for postage and handling will be charged if incorrect information is supplied resulting in the return of the application to the breeder/s.
